As a border state with significant trade with both Mexico and Canada, Arizona understands the importance of free trade for North America. In fact, Arizona's top two export markets are Mexico and Canada respectively, and more than 228,000 Arizona jobs depend on trade and investment from our neighbors, and in 2019, Mexico surpassed China to become the United States number one trading partner. How could the ratification of the USMCA change the nature of North American trade, and specifically, how will it impact Arizona?

At present, ratification of the updated United States-Mexico-Canada Agreement (USMCA) hangs in the balance, held captive by partisan interests and the politics of the upcoming election cycle in the U.S. House of Representatives, while the new agreement was ratified by the Mexican Senate in June and still awaits a vote in the Canadian Parliament. A product of two years of negotiations, the USMCA, or T-MEC or CUSMA, may take the relationship of the globe's most competitive trading block into the 21st century, with provisions for e-commerce, intellectual property protections, advanced rules of origin for the manufacturing sector, and expanded access for agriculture.

Arizona's economy stands to benefit from the new agreement, just as it expanded significantly over the 25 years under the North American Free Trade Agreement, which will remain in place unless further action is taken. The path forward remains to be defined, and there are many scenarios that could play out. It is at this moment of uncertainty and opportunity that the University of Arizona convenes a renowned group of experts to address the issues that face our state and to present an informed analysis of the potential impacts of the USMCA on the North American region.

We invite you to join us on October 30 to participate in this important forum on the future of North American trade, and to hear from experts and practitioners from the U.S., Mexico and Canada on how the North American region will evolve with or without ratification of the USMCA, and what the ramifications of those possibilities are for Arizona.
